Share buybacks in Skandinaviska Enskilda Banken AB (publ) during the period 6-10 November 2023

During the period 6-10 November 2023, Skandinaviska Enskilda Banken AB (publ) (LEI code F3JS33DEI6XQ4ZBPTN86) repurchased own Class A shares (ISIN: SE0000148884) for capital management purposes as follows:

The share repurchases are part of a SEK 1.25 billion share buyback program for capital management purposes, announced on 23 October 2023, running between 26 October and 29 December 2023, at the latest. The share buyback program is executed in accordance with the Market Abuse Regulation (EU) No 596/2014 ("MAR") and the Commission Delegated Regulation (EU) No 2016/1052 (the "Safe Harbour Regulation").

All acquisitions have been carried out on Nasdaq Stockholm Stock Exchange by Goldman Sachs Bank Europe SE on behalf of SEB. A full breakdown of the transactions is attached to this announcement.

Following the repurchases above, SEB holds 33,813,255 own Class A shares for capital purposes and 27,347,958 Class A shares for the bank's long-term incentive program. The total number of issued shares in SEB amounts to 2,139,983,495.

Share repurchases under the share buyback program may be temporarily halted for SEB's repurchases of shares for SEB's long-term incentive program.
