The share repurchases are part of a SEK 1.75bn share buyback program for capital management purposes running between 26 January and 18 March 2024, and a SEK 2bn share buyback program running between 20 March and 12 July 2024, at the latest. The share buyback programs are executed in accordance with the Market Abuse Regulation (EU) No 596/2014 ("MAR") and the Commission Delegated Regulation (EU) No 2016/1052 (the "Safe Harbour Regulation").

All acquisitions have been carried out on Nasdaq Stockholm Stock Exchange by Goldman Sachs Bank Europe SE on behalf of SEB. A full breakdown of the transactions is attached to this announcement.

Following the repurchases above, SEB holds 51,881,127 own Class A shares for capital purposes and 28 216 825 Class A shares for the bank's long-term incentive program. The total number of issued shares in SEB amounts to 2,139,983,495.

Share repurchases under the share buyback program may be temporarily halted for SEB's repurchases of shares for SEB's long-term incentive program.
