

**FINAL TERMS**

**for Loan No. SEBB601**

**under Skandinaviska Enskilda Banken AB (publ)'s Programme for Issuances of Covered Bonds**

The following are the final terms and conditions (“**Final Terms**”) of Loan No. SEBB601, (the “**Loan**”) that Skandinaviska Enskilda Banken AB (publ) (the “**Issuer**”) issues in the capital market in accordance with an agreement with the below mentioned Issuing House(s).

The Loan shall be subject to the general terms and conditions dated 7 July 2022 (the “**General Terms and Conditions**”) set out in the Issuer’s base prospectus for issuances of Covered Bonds, dated 7 July 2022 as supplemented from time to time (the “**Prospectus**”), and the Final Terms set out below.
